

ECEC Strategic Plan 2022-2024

The ECEC's basic aim is securing the quality, safety, sustainability and resiliency of design and construction based on the following indicators:

- 1. Continuous professional expert statements on relevant Engineering matters as a basis for lobbying and awareness-raising
- Promoting the European Green Deal and its policies (e.g. New European Bauhaus)
- Enhancing the understanding of the necessity of adequate professional regulations for engineers regarding the level of qualifications, professional conduct and responsibility and continuing professional development within the European institutions
- Enhancing fair procurement procedures for engineering services based primarily on quality instead of price competition only
- Enhancing fair remuneration
- Enhancing the approach that the use of BIM in public procurement projects needs to comply with basic requirements such as guaranteeing an "open BIM" as the most essential criterion to keep the market open for SME
- (Re-)Establishment of ECEC Working Groups with representatives of member organizations on current developments on relevant professional topics (such as BIM, Public Procurement, Education and regulatory issues, etc.)

2. Professional lobbying on the European and national level in the public interest

- Development of visions of future ECEC representation in Brussels and inquiry about possible cooperation with other institutions
- Maintaining and establishing contacts with EU institutions including those with consultative roles (European Economic and Social Committee and Committee of Regions)
- Promoting and conducting soft skills training for adequate lobbying communication
- Promoting and conducting know-how transfer of political decision-making procedures and relevant lobbying contacts
- Organization of and participation at events, meetings and webinars on a European level
- Establishment of a system of work-sharing within the Executive Board to allow specialization and focusing

3. Optimized visibility of ECEC

- Enhanced online presence (Social Media, Web, etc.)
- Enhanced accessibility of the ECEC website
- Implementation of a common event calendar on the Website
- Incorporation of ECEC logo + weblinks/current information on member's websites

4. International mobility of European Chartered Engineers

- Development of tools (e.g. information database on regulatory frameworks, etc.) to support professional cross-border activity
- Encouragement of bilateral agreements
- Lobbying for EU automatic recognition approaches for Engineers (e.g. Common Training Principles)
- Promotion of CPD measures on a European level

5. Cooperation with other Engineering Organizations on the European and national/regional level

- initiating common agreements
- Organizing common events such as European Engineers Day, etc.
- Developing common opinions on relevant professional matters
- Participation of Executive Board members at meetings of regional organizations (e.g. Višegrad, EIRC/IIRS, etc.)
- Closer contacts with regional organizations on current relevant matters
- Regular availability of ECEC Executive Board members for regional/local discussions and meetings

6. Enlarging the scope of representation of the ECEC

- Approaching new potential members which share the ECEC interests and fulfil the requirements of ECEC membership
- Approaching new potential associate members which share the ECEC interests
- Inviting member organizations to support this aim with their contacts
- Definition of benefits of membership
- Focus on inclusion of young professionals and diversity and equality
